Amount needed annually during the term of the levy is detailed as follows:

- 1. To provide for the hiring of 3 (three) Deputy Sheriff's in an effort to provide the children of our school system with a safe learning environment. One deputy will be assigned to Peterstown Elementary and Middle Schools, one will be assigned to James Monroe High School and Monroe Vocational Technical School and one will be assigned to Mountain View School. The deputies will also attend extra curricular events as deemed necessary. When school is not in session, these deputies will respond to emergency calls, take complaints, investigate crimes and assist in enforcing the laws of the State of West Virginia
 \$87,000.00
- 2. To provide for the hiring of 2 (two) Deputy Sheriffs in an effort o assist in responding to emergency calls, take complaints, investigate crimes and assist in enforcing the laws of the State of Vest Virginia \$58,000.00
- 3. To provide for the fringe benefits for the 5 (five) Deputy Sheriffs that will be assigned to our county schools. These benefits include retirement, state and federal taxes withholdings, health, dental and disability insurance, worker's compensation and social security \$105.000.00
- 4. To provide for the fuel for 5 (five) Deputy Sheriff's cruisers \$15,000.00
- 5. To provide for the maintenance for the 5 (five) Deputy She in scruisers \$9,000.00
- 6. To provide for the liability and comprehensive insurance for five (5) Deputy Sheriff's cruisers \$5,000.00

Total Annual Amount: \$279,000.00

One time expenditures to occur during the first year of the leaving are detailed as follows:

1. To provide for the purchase of five (5) police crusers at \$77,005.

2. To provide for the purchase of five (5) firearms at \$500.00 each \$2,590.00

3. To provide for the purchase of five (5) bullet proof vests and uniforms at \$1,300.00 each \$6,500.00.

4. To provide for the necessary training for five (5) deputies at a cost of \$2,008.00 each \$10,000.00

Total of one time expenditures: \$154,025.00

All according to the order of the Monroe County Commission entered on the 2nd day of January 2009. Any excess revenue generated by the levy will be used for the same purpose as described above.
